1. Welcome, Introductions and Apologies

Cllr Darren Price, Chair, welcomed everyone to the meeting.

2. Mid and West Wales Fire and Rescue Service Community Risk Management Plan

The PSB received a presentation from Mydrian Harries, the Fire and Rescue Service's PSB representative and Director of Resources.

The Service's 'Community Risk Management Plan 2040' was outlined to members. Its aim is to deliver the best possible Fire and Rescue Service for the communities of Mid and West Wales.

The Plan is currently out to consultation until 15 January and will be published on the Service's website on 31 March 2024.

This new strategic plan is aspirational and meets the need for one clear Strategy going forward with a single set of objectives, which looks longer-term, has a clear purpose focussing on prevention, protection and response and is based on the community and their needs. There is a clear implementation plan which is data led and evidence based.

Areas being consulted upon include draft Improvement and Well-being Objectives, on-call arrangements, reviewing risks, engagement, reviewing operational practices, vehicles and equipment requirements and the aim to become net zero by 2030.

Well-being Objective: Improving well-being and reducing health inequalities

3. Social Model for Health and Well-being

Nathan Davies, Senior Project Manager, Hywel Dda University Health Board, gave a presentation on behalf of Dr Phil Kloer, PSB member, Deputy Chief Executive and Executive Medical Director.

An outline was given of the background to the decision made to move towards a social model for health and well-being, following the Health Board's 20 year strategy 'A Healthier Mid and West Wales: Our Future Generations Living Well' (2018). This was because of the need to not just focus on medical or clinical care but to consider prevention and early intervention and to support connected and resilient communities where people are healthy and well.

Three broad areas of work had been proposed to the Hywel Dda University Health Board in June 2023 relating to:

- our workforce

- partners/partnerships
- communities.

A community in each county was identified, with partner organisations, to be a “test-bed” to support place-based community activity. In Carmarthenshire, Tyisha in Llanelli was agreed to be the area of focus. An outline was given of activity in the ward:

- Work with the Transforming Tyisha programme, making connections between the Transforming Tyisha team and primary care, work with the Children, Families and Communities workstream and with the County Council’s Disability Officer for Communities for Work Plus to consider possible volunteering opportunities
- Work with Ysgol Pen Rhos including the Moondance cancer initiative to raise awareness of bowel cancer and screening, information sessions from the Health Board’s Future Workforce team about examples of jobs and careers, and linking with a Swansea University research project to learn about how the school is practicing community-focused education and identify best practice
- Consideration being given to replicate the community based probation model seen at the ‘Grand Avenues’ project in Ely, Cardiff.

There was discussion around the social model being aligned to the wider determinants of health which can help target the root causes of ill health. Over two thirds of health issues are as a result of social, economic and commercial determinants rather than health causes.

It was noted that the County Council was working with Probation in relation to implementing the community payback programme.

4. Regional Partnership Board

A presentation was given by PSB member, Linda Jones, Programme Manager for West Wales Regional Partnership Board (RPB).

An outline was given of the requirements on the RPB to ensure the Local Authority and Health Board work together effectively to respond to the Population Needs Assessment and implement the joint regional Area Plan 2023-2028 and Annual Delivery Plan.

An update was given on progress around actions identified in the Population Needs Assessment, key projects agreed from the priorities from the Market Stability Report and progress on the key Year 1 actions in the Area Plan.

It was noted that one of the PSB’s key steps for 2023/24 is to strengthen the relationship between the PSB and RPB on areas of common interest including prevention. It is important to ensure the work of the PSB and RPB is aligned to avoid duplication.

There is a need to ensure effective alignment between the RPB and other strategic partnerships including PSBs and a mapping exercise is to be undertaken.

Discussion took place around prevention as a specific element of the RPB’s work which is relevant to the PSB. There is a need to consider how partners can be brought in to address low level

prevention needs and to support the population before there is a need for a health or social care service to be provided.

Initial work to be undertaken will be to analyse opportunities and barriers, map locations, discuss future infrastructure required and consider SLAs developed in other areas.

Much work had been undertaken in this area, including the workshop held last year, which needed to be considered to determine how it could be developed and built upon.

Members were advised that an initial meeting had been held with representatives from the Council, RPB, Coleg and Fire and Rescue Service. There was a need to map out the forums discussing this to avoid duplication. Information on work being undertaken by the RLSP would be reviewed.

A number of similar areas faced by partners had been identified including the recruitment challenge and links with young people in schools and Further and Higher Education to ensure opportunities in the public sector were considered as a career.

The group will next meet in December and will focus on planning how partners can address the recruitment challenge faced by all and how partners can network, share good practice and work collaboratively.
